# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.watersedgepoolcare.co, and Water's Edge Pool Care and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Water's Edge Pool Care include www.watersedgepoolcare.co and WEPC. The WEPC website is a Pool Service site. By using the WEPC website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

## **Sharing Information with Third Parties**

WEPC does not sell, rent or lease its customer lists to third parties.

#### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by WEPC. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the WEPC website.

- SSL Protocol

## **Right to Deletion**
